 Photographs of the audience who attended the event or photographs in which the people appear only as an accessory, on the basis of our legitimate interest in reporting on the event and its success.

You have the possibility to object to the use of such a photo in which you can be seen, in accordance with Article 21(1) DS-GVO. The association will check whether there are compelling reasons for the processing which are worthy of protection and which outweigh your interests, rights and freedoms. If not, the corresponding photo will be deleted.

Other photos in which an adult person (club member or from the public) is the focus or in which only this person has been specifically photographed will only be published with the consent of this person (Article 6 (1) sentence 1 a) DS-GVO). This consent can be revoked at any time for the future.

Newsletter

If you have subscribed to our newsletter, we will use your email address to send you the newsletter regularly and to provide you with interesting facts about the association. The legal basis for sending the newsletter is your consent (Article 6(1) sentence 1 a) DS-GVO). You can revoke your consent at any time to stop receiving the newsletter. To do so, you can click on "no newsletter" at the bottom of the newsletter email. Or you can write to us at newsletter.abmelden@kunstverein-ottobrunn.de or by post. We use our association software easyVerein or CleverReach to send the newsletter.

Data processing in the association

Registration data (surname, first name, date of birth, address, telephone, email, bank details, web address of the artists) are processed by the respective functionaries of our association only for the fulfilment of tasks assigned to them. In detail this means:

- If the Executive Board needs registration data to carry out its tasks, it may access
 all participant data required for this purpose. This includes, in particular,
 membership management, collection of membership fees, sending out
 participation information, sending out newsletters, organising exhibitions and
 events, as well as invitations to tender and art awards (Call for Entries).
- The treasurer processes the participation data relevant for the collection of the participation fees, the cash auditors process the participant data relevant for the cash audit. These are first name, surname, postal address and bank details with payment data as well as access to the direct debit authorisation including signature, if the artist has given the association a direct debit mandate.

The purpose for processing the participant data is the pursuit of the association's purpose and administration. The legal basis is the binding registration for the ARTiges 2023 competition (Article 6 (1) b) DS-GVO).

Recipients of the personal data

The data will be passed on to the following recipients:

Surname and first name, as well as photos of the artworks and portrait photos (so-called artist portraits) and the web addresses of these artists will be published in the context of solo and joint exhibitions (also online exhibitions), artist festivals and art prizes for the purpose of event announcement, promotion and reporting: in the local and national press, in particular Süddeutsche Zeitung, Münchner Merkur, Südostkurier, Mein Ottobrunn, In München, M:Art; as well as on our own website www.kunstverein-ottobrunn.de, websites of event partners and venues, furthermore via the social media platforms Facebook and Instagram.

Storage period

- The e-mail address that you have entered for the dispatch of the newsletter will be deleted as soon as you withdraw your consent to receive the newsletter, unless this e-mail address is also used for other communication than for sending the newsletter between the association and you.
- The current membership data will be stored for the duration of the membership and beyond for up to two years.



If we process personal data about you, you have the following data subject rights:

- a right to information about the data processed and to a copy,
- a right of rectification if we process incorrect data about you,
- a right to deletion, unless exceptions apply as to why we are still storing the data,
 e.g. retention obligations or limitation periods
- a right to restriction of processing,
- a right to withdraw consent to data processing at any time,
- a right to object to processing in the public or legitimate interest,
- a right to data portability,
- a right of appeal to a data protection supervisory authority if you find that we
 are not processing your data properly. The Bavarian State Office for Data
 Protection Supervision is responsible for our association. However, if you are in
 another federal state or not in Germany, you can also contact the data
 protection authority there.

The artist/group of artists consent to the taking and publication of photographs of works and portraits, so-called artist portraits, in the above-mentioned media and in the catalogue published for the event as part of the ARTiges 2023 Open Competition for the purpose of promoting the same.
